



## BOUND-T NO-COST SOFTWARE LICENCE

### 1. Definitions

This document is henceforth referred to as the **Licence**. The parties to this **Licence** are:

- Tidorum Ltd, which is a privately owned limited company registered in Finland, is represented by Mr. Niklas Holsti and is henceforth referred to as **Tidorum**, and
- Any person who downloads and uses a no-cost version of Bound-T from the Bound-T download site (<http://www.tidorum.fi/bound-t/download>), or who uses a such a version of Bound-T downloaded by some other person. Such a person is henceforth referred to as the **Licensee**.

The subject of this Licence is the computer program called Bound-T which is developed by Tidorum and Space Systems Finland Ltd and is owned by Tidorum. This Licence applies to all versions of Bound-T that Tidorum offers for no-cost download from the Bound-T website. Such versions of Bound-T are henceforth referred to as the **Software**.

If there are other software licence agreements between Tidorum and the Licensee, for Bound-T or other software, those other licences and their software deliveries are identified by distinct licence numbers and have no bearing on this Licence or vice versa.

Bound-T uses certain supporting programs (Omega Calculator, LP\_Solve) that are not the property of Tidorum. This Licence does not apply to such supporting programs and they are not included in the term Software even if they are downloaded from the same website as the Software.

### 2. Right to Use

Tidorum hereby grants the Licensee a non-exclusive right to install the Software on any number of computers and to use the Software subject to the terms and restrictions set forth in this Licence.

### 3. No Warranty

Tidorum has taken great care in developing and implementing Bound-T and believes that the Software works substantially as described in the Bound-T User Guide, Reference Manual and other documentation, all of which is accessible on the Bound-T web-site at [www.bound-t.com](http://www.bound-t.com). Nevertheless, Tidorum DOES NOT WARRANT that Bound-T is correct and accepts NO RESPONSIBILITY OR LIABILITY for direct or indirect damages that may result from the Licensee's use of the Software or the results generated by the Software. The Software is provided "as is" and the Licensee uses the Software and its results at the Licensee's own risk.

### 4. No Removal of Functional Limitations

Tidorum may have introduced functional limitations in the Software (the no-cost versions of Bound-T), such as (but not limited to) an upper limit on the size of target programs that can be analysed, or limitations on the kinds of analysis or outputs that the Software offers. The Licensee shall not modify the Software to remove such functional limitations.

### 5. No Transfer of Ownership or Intellectual Property Rights

This Licence does not imply any transfer of ownership or intellectual property rights from Tidorum to the Licensee. The Licensee may use (execute) the Software and use the results of the execution but the Software remains the property of Tidorum.

### 6. Termination and Jurisdiction

Tidorum can terminate this Licence at any time if the Licensee violates the conditions of the Licence. The Licensee shall then cease to use the Software. The Licensee can terminate this Licence at any time by ceasing to use the Software. The laws of Finland apply to this Licence. Disputes will be resolved amicably when possible and otherwise at the Court of Helsinki.
